Declaration by parents

It is clearly understood that in case we are not in consonance with or in agreement with the afore and/or supra we have no right of entry.

It is clearly understood that:

- a) Grant of admission is not a right to enter the school.
- b) In case of violation of the rules, norms, guidelines or failure to follow instructions, the permission of entry is lost.
- c) All the fee amounts including the transportation fee is payable in advance.

We undertake that:

1. We have sought admission for our child in this institution with our own volition and interest.
2. We are aware of the rules and regulations of this institution and will follow them as well as see to it that our child follows the same.
3. We are aware of the fees structure and it is our responsibility to pay the fees on time and that in case it is not made on time the child loses right to enter the school.

4. We will not interfere in the day to day activities of the institution.
5. We will visit the school premises only on the scheduled time of visit or seek prior permission to do so.
6. We will not disturb the teachers over phone and will only contact them as per the rules and instructions of the school.
7. We give the right to take necessary disciplinary action on our child if found violating the school discipline or rules.
8. We will not malign the name of the school in public or over social media.
9. We will not take part in any activity that is against the interest of Chinmaya fraternity including the school, the mission, the trust, its officials, its trustees, its representatives or its staff.

We agree that:

- I. The school has the right to limit the school activities relating to our child to online mode alone in case of unruly behavior by our ward, non payment of fees, failure on our and/or our ward to follow the rules of the institution and directions of its staff and management.
- II. The school has the right to terminate the permission of entry to our child to school in case of any of the above deeds, violations, laches misbehavior by us or the ward to the teachers.
- III. The institution has the right to terminate the transportation facility in case the transportation fee is not paid in advance.
- IV. The institution has the right to adjust the amount paid by us to whatever account that is due or is payable in advance.
- V. Any communication send in any mode of the address mentioned in the annexure is sufficient notice to us.
